



LEGAL DISCLOSURES FOR BENEFITS UNDER THE CONOCOPHILLIPS MEDICAL AND DENTAL ASSISTANCE PLAN AND THE CONOCOPHILLIPS RETIREF MEDICAL AND DENTAL PLAN

Women's Health and Cancer Rights Act (WHCRA)

Do you know that your plan, as required by the Women's Health and Cancer Rights Act of 1998, provides benefits for mastectomy-related services including all stages of reconstruction and surgery to achieve symmetry between the breasts, prostheses, and complications resulting from a mastectomy, including lymphedema? Special HIPAA Notice

The ConocoPhillips Medical and Dental Assistance Plan, the ConocoPhillips Retiree Medical and Dental Plan, the ConocoPhillips Employee Assistance Plan, and the ConocoPhillips Flexible Spending Plan are required by the Health Insurance Portability and Accountability Act of 1996 (HIPAA) to maintain the confidentiality of your individually identifiable health information. A detailed description of how your medical information may be used, as well as your rights to access your medical information is described in the HIPAA Notice of Privacy Practices (NPP).

Premium Assistance Under Medicaid and the Children's Health Insurance Program (CHIP)

If you or your children are eligible for Medicaid or CHIP and you're eligible for health coverage from your employer, your state may have a premium assistance program that can help pay for coverage, using funds from their Medicaid or CHIP programs. If you or your children aren't eligible for Medicaid or CHIP, you won't be eligible for these premium assistance programs but you may be able to buy individual insurance coverage through the Health Insurance Marketplace. For more information, visit www.healthcare.gov.

If you or your dependents are already enrolled in Medicaid or CHIP and you live in a State listed below, contact your State Medicaid or CHIP office to find out if premium assistance is available.

If you or your dependents are NOT currently enrolled in Medicaid or CHIP, and you think you or any of your dependents might be eligible for either of these programs, contact your State Medicaid or CHIP office or dial **1-877-KIDS NOW** or http://www.insurekidsnow.gov to find out how to apply. If you qualify, ask your State if it has a program that might help you pay the premiums for an employer-sponsored plan.

If you or your dependents are eligible for premium assistance under Medicaid or CHIP, as well as eligible under your employer plan, your employer must allow you to enroll in your employer plan if you aren't already enrolled. This is called a "special enrollment" opportunity, and **you must request coverage within 60 days of being determined eligible for premium assistance**.
